		<ul> <li>On or after July 1, 2022, you were homeless or at risk of being homeless</li> <li>"Homeless" means you lacked fixed, regular and adequate housing, and you lived in shelters, motels or cars, or temporarily lived with other people because you had nowhere else to go.</li> <li>"Unaccompanied" means you are not living in the physical custody of your parent or guardian.</li> <li>"Youth" means that you are 23 years of age or younger or you are still enrolled in high school as of the day you signed the FAFSA.</li> <li>Attach documentation from the homeless liaison or director of the shelter/program that verified your status.
