Faculty, staff, and administrators participate in "Accessibility Training" sessions

As our world becomes increasingly digital, ensuring our digital services are accessible to all students and the public is critical in fulfilling our mission statement, as well as complying with ADA regulations. Gaier Dietrich of the State Chancellor's High Tech Center Training Unit taught the accessibility training sessions. Faculty, staff, and administrators learned about the upcoming updates to Section 508 as well as how to create accessible materials for students and employees.

Students share insight at the Fall Planning Retreat

The 2nd annual Fall Planning Retreat was held on September 15, and nearly 75 faculty, staff, students, and administrators in attendance. Four students served on a panel and shared insights about their positive experiences at Clovis Community College. Participants reviewed the Mission and Values and connected them to the college's integrated planning and resource allocation models. In addition, attendees reviewed and discussed the Quality Focus Essay (QFE) that will be submitted to the ACCJC as a part of the college's "Institutional Self-Evaluation Report." The group started on Project 2 of the QFE, which focuses on using data in the college's decision-making processes.

Program Review Process update

The College Council convened an Ad Hoc group to begin a thorough review of the Clovis Community College Program Review process. With the assistance of an outside consultant, the group is creating a Program Review process that is efficient, transparent, and effective. The group will continue their work throughout the semester, then submit a draft to the constituency groups.
