Accreditation Mid-Term Update

At its January meeting, the ACCJC acted to reaffirm Clovis Community College's accreditation for the remainder of our accreditation cycle on the basis of our Follow-Up Report. That's great news! Now, we can focus our attention on completing our first Midterm Report, which is due March 15, 2022. In our Midterm Report, ACCJC asks that we address the following:

- Actionable Improvement Plans in our 2018 ISER
- Response to Team Recommendations
- Data Trend Analysis (on specific data elements)
- Report on the Outcomes of the Quality Focus Essay Projects

The Accreditation Steering Committee has been tracking the progress on the activities for each of these requirements, and the College is on track for a successful Report. More focused work on the Midterm Report, including collecting evidence and drafting narrative, will begin in Fall 2020.

On Wednesday, February 12, a Facilities Town Hall was held to give faculty, staff and students the opportunity to see plans for the exterior of our new 66,000 square foot Career Technical Education Building. Darden Architects has been meeting with faculty, staff and administrators since October 2019 to determine locations of classrooms, labs, offices and student spaces. Outcomes & Assessment Update

The Outcomes and Assessment committee has been preparing a report addressing our college efforts to meet the ILOs. This report is supported by SLO mapping in eLumen, and we are close to 75% of all SLOs being mapped to ILOs. Additionally, the report uses student data from our graduation surveys, and the CCSSE survey. Future reports will focus on individual ILOs. We have migrated to eLumen for SLOs. Faculty coordinators are responsible for entering data into eLumen and submitting the reflection. Training is available for faculty coordinators.

Institutional Research Update

The Office of Institutional Research has been busy working on a wide variety of research and planning projects including, but not limited to, providing data and support for the UP Plans, providing data and assistance for the TRIO SSS and STEM and the Title V grant proposals, evaluating the outcomes for math and English due to AB-705 changes, developing and fielding surveys on a variety of topics, and many ad hoc requests.

This semester, we continue to focus on completing the Quality Focus Essay Action Project #1 – Strengthening the Use of Data in Decision Making. The project includes four primary goals:

- 1. Expand internal and external data available in an easy-to-use and understand format.
- 2. Inform faculty, staff, and administrators about where to access existing data.
- 3. Provide professional development for College constituents to better understand the data.
- 4. Promote the use of data to make improvements.

Additionally, we are moving forward with the research activities from the recently approved IEPI PRT grant and will be receiving our Survey of Entering Student Engagement data soon. Finally, we are excited to work with the recently approved Institutional Effectiveness Advisory group to continue to promote a culture of evidence and inquiry. We were very happy with the level of engagement with the data activities on opening day and at the college retreat and are enthusiastic to continue these conversations in the advisory meetings.

Budget Update

The Governor released his proposed budget on January 10. Included in the proposal was new on-going funding of \$11 million for Food Pantries and \$10 million for Immigrant Legal Services through DSS. State Center Community College District's portion is estimated to be about \$275,000 for Food Pantries and about \$250,000 for Immigrant Legal Services. There is also new one-time funding included for a Statewide Fellowship Pilot Program in the amount of \$15 million for community colleges. SCCCD's portion will be about \$375. The purpose of the program is to improve faculty diversity at community colleges through recruitment and mentorship.

The Student Centered Funding Formula for 2020-21 is proposed to stay the same:

70% Base Allocation (FTES)

20% Supplemental Allocation (Pell, California Promise Grant, AB540 Students)

10% Student Success Allocation (Associate Degrees for Transfer, Local Degrees and Certificates)

Funding rates in 2019-20 will be adjusted for COLA. Cost of Living Adjustment for 2020-21 is currently 2.29%

In mid-May the Governor will release the May Revise which will include the latest economic forecasts.
